

2024 Registration changes are here

Are you CPD ready?



For ongoing medical registration, doctors must join an Australian Medical Council (AMC) approved CPD home.

Since 1 January 2024, Australian doctors must now comply with the new CPD registration standard. Under the Medical Board of Australia's new Registration Standard: *Continuing professional development* (the Standard), Australian doctors requiring a CPD home can no longer self manage their CPD, and must join an Australian Medical Council (AMC) approved CPD home.

What are CPD homes?





CPD homes are AMC accredited providers that help doctors meet the Standard.

Your CPD home will help you to plan and track CPD activities relevant to your scope of practice, and report your annual compliance to Ahpra.



Does this affect me?

Australian registered doctors who are now required to subscribe to a CPD home include:

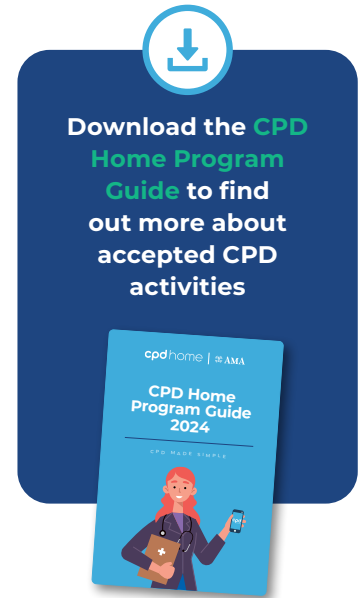
-  medical specialists
-  IMG's not on a specialist pathway, with limited or provisional registration
-  PGY3+ doctors not in a specialty training program
-  all other general registration doctors including non-vocationally registered medical practitioners.

Mandatory CPD requirements

To meet the Standard, doctors are required to:

1. write a **CPD plan**
2. meet the **minimum hour requirements** across the two domains of learning (below), including high-level CPD requirements approved by MBA where relevant to your registered scope of practice
3. reflect on your **planned learning goals** at the end of the CPD year.

Your **CPD home will submit** your CPD compliance to the Australian Health Practitioner Regulation Agency (Ahpra).
